Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (Rt.) No. 381/2015/Law dated 31st March, 2015 and published as S. R. O. No. 193/2015 in the Kerala Gazette Extraordinary No. 753 dated 31st March, 2015, the Government of Kerala appointed Smt. Mary Irin, Sub Registrar, Perambra in Kozhikode District and Shri T. Johnson, Sub Registrar, Vadakkanchery, Palakkad District as Marriage Registrars for the local area of jurisdiction in Kozhikode District and Palakkad District (except the erstwhile Cochin area) under section 7 of the Indian Christian Marriage Act, 1872 (Central Act XV of 1872). Consequent to the transfer of Marriage Registrar's, the Government have now decided to appoint Smt. Mary Irin, Sub Registrar, Kuttiyadi as Marriage Registrar in Kozhikode District and Shri T. Johnson, Sub Registrar, Kuzhalmandom as Marriage Registrar in Palakkad District (except the erstwhile Cochin area) and to make consequential amendment to the said notification.

The notification is intended to achieve the above object.
